

**RECRUITMENT NOTIFICATION FOR THE POSTS OF TEACHING AND NON-TEACHING STAFF AT NAVY CHILDREN SCHOOL, CHANAKYAPURI, NEW DELHI**

1. Applications are invited for filling up of posts of Teaching and Non-Teaching staff at the Navy Children School, Chanakyapuri, New Delhi on regular/ contractual basis as mentioned in the proceeding paragraphs.

2. **PGT (English) on Regular Basis.** Eligibility Criteria is as given below:-

(a) Master's Degree in English completed as regular course with at least 55% marks from recognised university/ institution.

(b) Bachelor of Education in relevant subject as a regular course and qualified with at least 50% marks from recognised university/ institution.

(c) Should have studied the English at Sr Secondary and Graduation level.

(d) Age limit - 30 Years (40 Years for women candidates) (Relaxable for applicants with relevant NCS experience).

(e) Experience of teaching relevant subject in recognised CBSE schools would be desirable.

3. **School Counsellor on Contractual Basis.** Eligibility Criteria is as given below:-

(a) Master's degree in Psychology with one year Certificate/ Diploma in Counselling.

(b) Valid registration with the Rehabilitation Council of India would be desirable.

(c) Age limit - 30 Years (Relaxable for applicants with relevant NCS experience).

(d) Experience in providing counseling to students at CBSE affiliated schools would be desirable.

4. **Special Educator on Contractual Basis.** Eligibility Criteria is as given below:-

(a) Graduate with B Ed (Special Education) or B Ed with two year Diploma in Special Education or Post Graduate Professional Diploma in Special Education.

Or

Any other equivalent qualification approved by Rehabilitation Council of India as a regular course and qualified with at least 50% marks from recognized university/ institution.

(c) Age limit - 30 Years (40 Years for women candidates) (Relaxable for applicants with relevant NCS experience).

(d) Experience of teaching Special children in recognized CBSE schools would be desirable.

5. **Primary Teachers on Contractual Basis**. Eligibility Criteria is as given below:-

- (a) BA/ BSc/ BCom/ B Tech/ BBA Degree completed as a regular course with at least 55% marks from recognised university/ institution.
- (b) Bachelor of Education studied as a regular course and qualified with at least 50% marks from recognised university/ institutions.
- (c) Age limit - 30 Years (40 Years for women candidates) (Relaxable for applicants with relevant NCS experience).
- (d) Experience of teaching in recognised CBSE schools would be desirable.

6. **Lab Assistant (Science Lab) on Contractual Basis**. Eligibility Criteria is as given below:-

- (a) B Sc with Physics/ Chemistry/ Biology Degree completed as a regular course with 50% marks.
- (b) Age limit - 27 Years. (Relaxable for applicants with relevant NCS experience).
- (c) Experience in recognised CBSE schools would be desirable.
